\*Each vendor must have a license from the City of Pasadena. If you do not have one, a one-day permit can be obtained once you have registered for the event.

\*\*A seller's permit is required only if you plan to sell items during the event. You do not need a seller's permit if you will only hand out prizes, promotional items, information, or other giveaways. If you are selling items and don't have a permit, a temporary one can be obtained at https://www.cdtfa.ca.gov/industry/temporary-sellers.htm.

Pasadena Humane reserves the right to remove, decline, or prohibit any vendor which, in its opinion, is not suitable to or in keeping with the character of the Wiggle Waggle Walk & Run.

### WIGGLE WAGGLE WALK & RUN VENDOR RULES AND REGULATIONS FORM

- 1. Qualifications to Exhibit: Pasadena Humane reserves the right to remove, decline, or prohibit any exhibit or part of an exhibit, or proposed exhibit which, in its opinion, is not suitable to or in keeping with the character of the Wiggle Waggle Walk & Run. Pasadena Humane forbids the selling or displaying of choke chains, prong collars, shocking devices (including collars and fences), animal fur, or any other product that may cause harm or pain to an animal.
- 2. Location of Exhibit: The Exhibitor agrees to confine their presentation within the contracted space only and to maintain a staff member in their booth space during Wiggle Waggle Walk & Run hours. Pasadena Humane reserves the right, at all times, to relocate an exhibitor as it shall deem necessary for the proper conduct of the Wiggle Waggle Walk & Run.
- 3. Exhibit Installation and Removal: The Exhibitor agrees that no display may be dismantled or goods removed during the Wiggle Waggle Walk & Run. All booths must remain intact until after the closing time of the Wiggle Waggle Walk & Run. Exhibitor also agrees to remove exhibit and equipment from the show area by the final move-out time.
- 4. Sub-license of Space: Space contracted by Exhibitor may not be sublet without prior written permission from the Pasadena Humane.
- 5. Use of Pasadena Humane Logo: Exhibitor may only use the Pasadena Humane logo with the express written permission of Pasadena Humane.
- 6. Food and Beverages: All Exhibitors who intend to prepare, sell or give away food and beverage items MUST comply with all City of Pasadena rules and regulations. Pasadena Humane will not be responsible for obtaining required permits or paying any required fees for the preparation, cooking, selling or giving away of food and beverage items. The Exhibitor agrees to produce a copy of any required permits and proof of payment of any required fees upon request application. Exhibitor further agrees to hold Pasadena Humane harmless for any and all damages, fines and/or penalties incurred as a result of a food and/or beverage Exhibitor's failure to comply with all City requirements.
- 7. Cancellation of Contract: Pasadena Humane reserves the right to terminate this contract and to withhold from the Exhibitor possession of the exhibit space if: (a) the Exhibitor fails to pay all space rental charges or (b) the Exhibitor fails to perform any terms and conditions of this contract, or (c) the Exhibitor fails to comply with all licensing requirements for the City of Pasadena.
- 8. Cancellation Policy: In the event an Exhibitor wishes to cancel six weeks prior to event, a refund of 50% of paid fees will be made upon receipt of written cancellation. No refund of paid fees will be given after 30 days before the event or in the event of rain.
- 9. Postponement or Cancellation by Pasadena Humane: Pasadena Humane reserves the right to postpone or cancel the event at its discretion. In the event of such a cancellation, all monies will be refunded to exhibitors.
- 10. Insurance and Indemnification: The Exhibitor agrees to add Pasadena Humane and the City of Pasadena as additional insured to any existing general liability insurance policy with a minimum liability of \$1 million for the day of the event and to provide proof of said insurance upon application. Pasadena Humane reserves the right to require any vendor to obtain general liability insurance and add Pasadena Humane and City of Pasadena as additional insured, pursuant to the terms set forth above, for the day of the event as a condition of approving the application.

Exhibitor shall indemnify, defend and hold harmless Pasadena Humane and the City of Pasadena, and their respective directors, officers, agents, employees and volunteers, from and against any claims, demands, causes of action or damages (including attorneys' fees) arising out of the use by Exhibitor and occupancy of the Premises, any taxes, fees, fines, penalties assessed by any government or non-government entity against either Exhibitor or Pasadena Humane based on Exhibitor's Agreed Use (or unauthorized use) of the Premises, any breach of the Rules and Regulations, any negligence or willful misconduct by Exhibitor, or any alleged defects or inherent dangers in connection with the Exhibit.

11. Damages: Pasadena Humane shall not be liable for any damages, whether direct, indirect, general, special, consequential, punitive, or otherwise to Exhibitor, its product or exhibit, its agents and employees or visitors to its exhibit whether occasioned by Pasadena Humane, its volunteers, Board Members, agents or employees, or by another Exhibitor, and its agents and employees.
